Applications and payment must be submitted to the Association office:

First Installment: due by November 1st

Second Installment: due by May 1st

Should a same site camper fail to pay the required fees by the required dates, Lake Wildwood Association assumes they no longer wish to maintain their site and they must immediately remove their camper from the site. The next member in good standing on the waiting list will be offered the site. If applicant's name is on the waiting list, the first available site must be accepted by applicant or his/her name will go to the bottom of the list as of that date.

- I understand that if the November or May payments are not received on time and my camper is not removed from the site, it may be towed at my expense and the site will be offered to the next person on the waiting list.
- I understand that I will not be billed for either of the payment dates.
- I understand that I must be a member in good standing and have 20 days of camping in the previous season in order to remain in my present site and be eligible for same site camping.

Lake Wildwood Association, Inc. reserves the right to reject applications from members who have violated the Lake Wildwood Association, Inc. Rules and Regulations or in the opinion of the Board of Directors whose behavior has not contributed to the peace and tranquility of the Lake Wildwood campground.

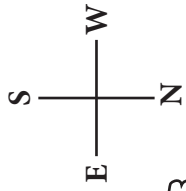
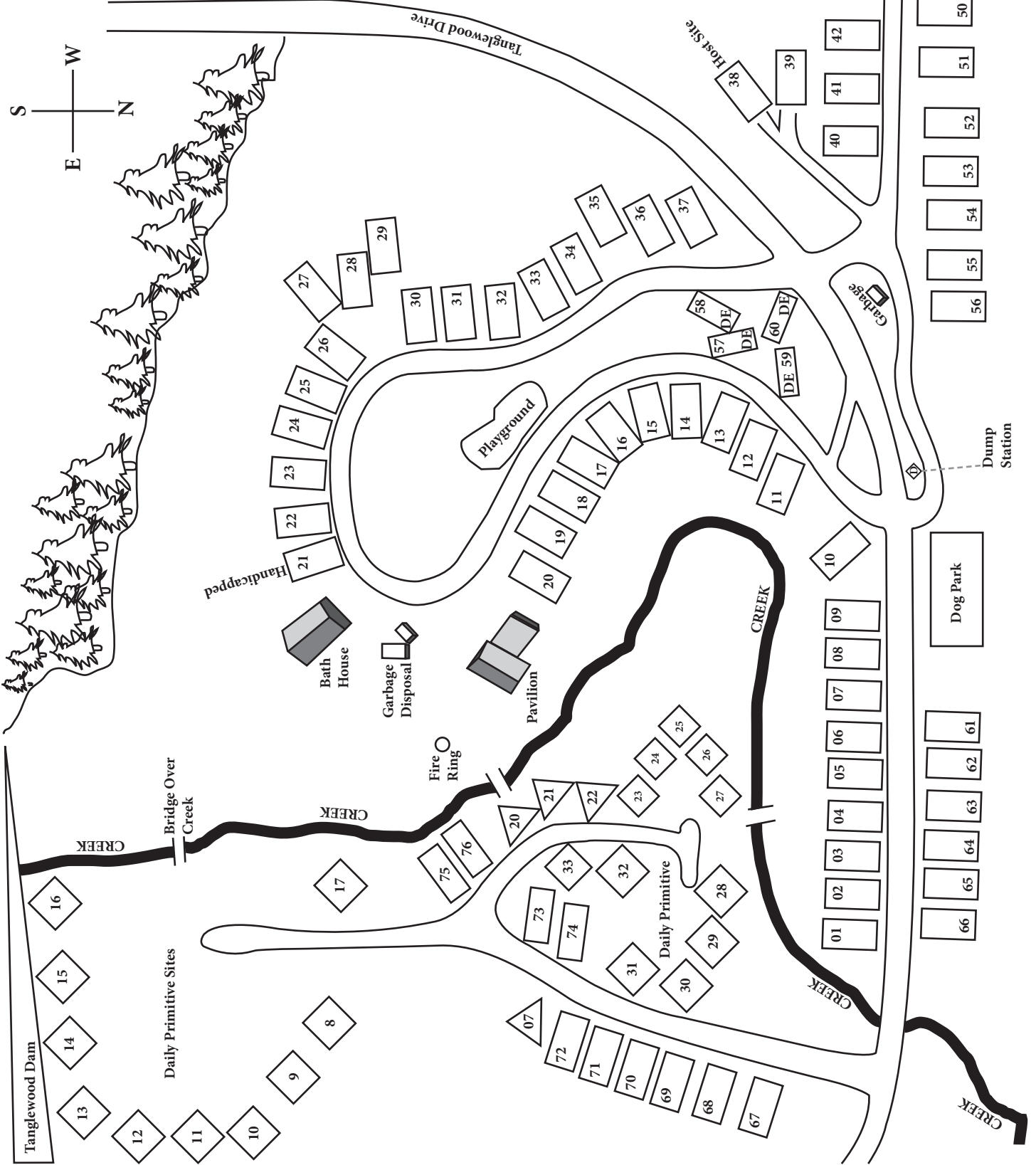
