**WAITLIST OPENS NOVEMBER 3**

The timestamped waitlist opens **Monday, November 3rd**. In order to be added to the waitlist, members must submit the following:

**REGISTRATION**

Marina Slips are available only to members in good standing with a currently registered watercraft unit.

Watercraft require updated insurance and a current, valid State DNR in order to receive a Lake Wildwood Marine Decal.

**TWO FLAG RULE**

A friendly reminder that the provisions of the State of Illinois Boat Registration and Safety Act have been adopted by the Association to be applicable to all watercraft operated on lakes Wildwood and Tanglewood. As such, the following flags are required when skiing and towing:

**SKIING**

A downed skier warning flag is required equipment for towing. It must be bright orange and a minimum of 12" square. The flag is to be displayed by the spotter when a person is downed and must be visible for 360°.

**TOWING**

Per Illinois DNR, any boat towing a person must display a bright orange flag at least 12 inches on each side. The flag has to be mounted high near the helm, visible from all directions, and remain up the entire time the person is in the water.

**RENTAL AGREEMENT**

- (1) Abide by the Rules and Regulations governing use of the area within Lake Wildwood designated as the Marina and to assume all responsibility for placement in assigned slip and removal of said unit by November 1.
- (2) To authorize Lake Wildwood and its designated agents to move said watercraft from assigned slip for the purpose of maintenance to boat slips.
- (3) To reimburse any costs incurred to Lake Wildwood due to any damage that may occur to the boat slips as a result of your operations and mooring of said watercraft.
- (4) To release and forever discharge Lake Wildwood Association, Inc. and all persons a part of the Lake Wildwood Association, Inc. from any and all claims, demands, and causes of action by reason of damage, vandalism, theft, or loss of watercraft: and together with any personal property contained in said watercraft.
- (5) Assignment is contingent upon availability of boat slip and is not guaranteed by submission of the *Marina Slip Application*.
- (6) The undersigned hereby agrees to pay a sum of **\$1,000.00** for a lease commencing **April 1, 2026** and ending **November 1, 2026**. Failure to remit payment will result in loss of slip assignment.
- (7) Only watercraft registered to the member selected for a slip assignment may be parked in the assigned slip. Violation of this rule will result in loss of slip and full rental payment.
- (8) Trading of slips is allowed only between members who were selected for a slip assignment. The office must be notified prior to any trades.
- (9) Persons born on or after January 1, 1998, may operate a vessel powered by a motor of more than 10 horsepower (hp) **only** if they have a valid Boating Safety Certificate accepted by the Department of Natural Resources.
