

NEW CAMPER REGISTRATION

Member-owned camping units must be registered with Lake Wildwood Association

Application to be filled out by the member of the Association only.

All member-owned camping units require clearly displayed lot numbers.

Lot numbers (min. 3" tall) must be displayed on the driver side, on the forward window, or on the forward portion of the vehicle.

Proof of ownership (title or license registration) and proof of liability insurance coverage (covering bodily injury and property damage; \$100,000 min.) are required with the submission of this application.

The Undersigned Acknowledge and Agrees as Follows:

- 1. To abide by the stated Rules & Regulations governing use of the area designated within Lake Wildwood as "Campground" and/or "Storage Area(s)."
- $2. \ To \ assume \ all \ responsibility \ for \ placement, \ maintenance \ and \ storage \ of \ said \ unit \ within \ the \ designated \ Campground \ and \ / \ or \ Storage \ Area(s).$
- 3. To authorize Lake Wildwood Association and/or its designated agent(s) to move or remove said unit from any assigned Campground site and/or Storage Area(s).
 - i. Necessary maintenance of the Campground and/or Storage Area(s), or,
 - ii. should said unit's presence there be in violation of stated Rules & Regulations (including, but not limited to, 16-day site stay limit).
- 4. To reimburse any costs incurred to Lake Wildwood Association, Inc. through the moving or removal of said unit as judged necessary as a result of violation of any stated Rules & Regulations.
- 5. To release and forever discharge Lake Wildwood Association, Inc. and all persons a part of Lake Wildwood Association, Inc. from any and all claims, demands and causes of action by reason of any damage, vandalism, theft or loss of any trailer or like vehicle; together with any personal property contained therein while being maintained and/or stored in Campground and/or Storage Area(s), including but not limited to, the performance and/or acts of maintaining and improving of Campground and/or Storage Area(s) by Lake Wildwood Association, Inc. and/or its designated agent(s).
- 6. To provide the Association with a copy of Certificate of Insurance qualifying Bodily Injury & Property Damage while the unit is parked and/or stored on Association property (\$100,000 minimum) and a copy of either current license registration or title proving ownership. Three-inch (size) lot numbers must be clearly displayed on the driver's side, on the forward window or on the forward portion of the vehicle.
